With reference to Govt. of India's letter No.CD-I-11/2/2016-CD.I dated 06.10.2017 in supersession of this Department's all the previous Order vide Memo. No.8058-SW dated.26.12.2012, Memo. No.1577(2)-SW dated.07.05.2013 & Memo. No.4115(2)-SW dated.28.11.2014, I am directed by order of the Governor to say that the Governor has been pleased to enhance the rates of Supplementary Nutrition(SNP) under the Anganwadi Services of Umbrella ICDS Scheme throughout State w.e.f 01.01.2018 as per the following table:

Beneficiary	Present rate	Revised rate
Children (6-72 months)	Rs.6/- per day per children	Rs.8/- per day per child
Pregnant and Lactating mothers	Rs.7/- per day per children	Rs.9.50/- per day per child
Severely malnourished children (6-72 months)	Rs.9/- per beneficiary per day	Rs.12/- per beneficiary per day.


The expenditure will be incurred for the above-mentioned enhancement of rates by the State Govt. and Central Govt. on 50:50 basis from the following Head of Accounts:


