Sir,

In accordance to Para-5 of Finance Department Memorandum No. 3425-F(P2), dated 30/05/2018, the undersigned is directed by order of the Governor to say that the Governor is pleased to decide that all the eligible Anganwadi Workers and Anganwadi Helpers of ICDS Scheme (Both Govt. run and NGO-run ICDS Projects) will be entitled to ex-gratia for the accounting year 2017-18 @ Rs. 3800/- (Three thousand eight hundred) only per head. The benefit of ex-gratia will be admissible subject to the following terms and conditions:

- 1) The Anganwadi Workers and Anganwadi Helpers of ICDS Scheme (Both Govt. run and NGO-run ICDS Projects) who were in service on 31.03.2018 and rendered at least 6 (six) months continuous service during 2017-18 will be entitled for payment of Ex-gratia under this order.
- 2) The Governor is further pleased to direct that the disbursement of Ex-gratia sanctioned herein above should be made in respect of Muslim Anganwadi Workers and Anganwadi Helpers of ICDS Scheme (Both Govt. run and NGO-run ICDS Projects) by 8th June, 2018.
- 3) In case of failure, the disbursement should be made as early as possible before the festival of Id-UI-Fitre.
- 4) The amount of Ex-gratia payable to the eligible Muslim Anganwadi Workers and Anganwadi Helpers of ICDS Scheme (Both Govt. run and NGO-run ICDS Projects) @ Rs. 3800/- (Three thousand eight hundred) only per head, for the accounting year 2017-18 will be debited from the following heads of accounts as per **Annexure-I & II**:
