Sub: Hiring/Procurement of vehicles under ICDS Scheme during XI Five Year Plan Period – reg.


Sir/Madam,

I am directed to refer to this Ministry's letter No.5-3/2000-CD-1(Vol II) dated 17<sup>th</sup> January, 2003 on the subject mentioned above and to say that procurement/hiring of vehicles under the ICDS Scheme has been reviewed by the Government. It has now been decided to permit hiring of vehicles strictly in accordance with the following:


- i. The hiring of vehicles in existing Projects/District Cells may be undertaken @ **Rs.2.15 lakh** per vehicle per annum, which also connotes a maximum ceiling.
- ii. The hiring of vehicles may be undertaken in existing Projects and Districts Cells on replacement basis against the vehicles which have been duly certified to be condemned.
- iii. States are also permitted to hire vehicles in all new Projects.
- iv. As special dispensation, purchase of vehicles @ **Rs.7.00 lakh** per vehicle or the actual price, whichever is less, is permitted for the North Eastern States and the State of Jammu and Kashmir to ensure the much required mobility for effective implementation and monitoring of the Scheme.
- v. The vehicles have to be procured in accordance with the procedure laid down under the General Financial Rules applicable to the State or at the rates approved by DGS&D.

2. State Governments/UT Administrations are requested to furnish their requirement of vehicles on replacement basis during financial year **2009-10** in the enclosed **Proforma I**.
3. Governments of North Eastern States and Jammu & Kashmir are requested to furnish their requirement of vehicles to be procured during the financial year 2009-10 in the enclosed **Proforma II**.
