




FOREWORD

Preface

Child Protection Services Scheme (CPS) requires the state to establish, promote and strengthen community-based child protection mechanism that recognizes, promotes, and protects child rights at the grass root level. Child Protection Committee (CPC) is one such community-based child protection mechanisms in the community to safeguard the rights of children and take appropriate measures to prevent and address the issues of child rights violations.

This guideline for Child Protection Committee (CPC) is developed considering the norms and vision of Child Protection Services with the following objectives:

- 1. Complying with cardinal principles of the best interest of the children and protection of child rights.
- 2. Building community awareness and consciousness on child rights.
- 3. Promoting behavioral changes of the parents and community.
- 4. Monitoring and reporting of child rights violation cases in the community, to respond and if required refer it to the appropriate authorities.
- 5. To raise awareness in the community about Government programmes and schemes for children.
- 6. Identify vulnerable children of the community and prepare child protection plan covering each child and sharing it with concerned competent authorities.
- 7. Facilitating implementation and follow up.

1. Introduction:

The Child Protection Committee is expected to create a safety net and child friendly environment at the grass root level. In 2015 the guidelines for the formation and strengthening of Child Protection Committees in West Bengal at the village and Block/Ward level was published by the Department of Women & Child Development and Social Welfare, Government of West Bengal.

With the passage of time, the need was felt to review the structure and functions of CPC particularly by:

- ❖ Introducing a Gram Panchayat Level committee as an additional tier in between Block Level Child Protection Committee and Village Level Child Protection Committee.
- ❖ Inducting the office bearers of the Self-Help Group federations which are a dedicated women forum committed to social and economic development at the village level.

Objective of Child Protection committee (CPC)

- A) A CPC is a community-based group including duty-bearers, who are primarily responsible for creating and promoting a child friendly and safe community environment wherein children's wellbeing, safety and rights are ensured and protected.
- B) CPCs will be responsible for monitoring, reporting, and responding to the issues of child protection in the community.
- C) The CPCs will also plan and take up innovative activities to raise awareness in the community about the local child protection concerns.
- D) The CPCs will work in close coordination with the District Child Protection Unit and other agencies for activities in the community on child protection issues.
- E) CPCs will refer and report cases to higher level of Protection committees and District child Protection Unit.

Child Protection Committee at various levels:

The CPCs will be at three levels, at the village, Gram Panchayet and block/ ward level. The District Child Protection Unit will coordinate at the district level for child protection concerns. Over all coordination in the state will be done by West Bengal State Child Protection Society.

Level 1. Village Level and Ward level

Village level Child Protection Committees (VLCPC):

The village level Child Protection Committees will be established in each village (Gram Samsad) of state for prevention, reporting, monitoring, protection and responding on the issues of child rights and protection. The VLCPC will be a community-based organization and act as the **first responder in any situation of child vulnerability.**

Ward Level Child Protection Committees in Urban Area (WLCPC): The WLCPCs will be formed in each ward of the municipalities/municipal corporations and will report to DCPU. The purpose of the WLCPC will be to monitor, report, respond, refer, and raise awareness among the community for protection of children under the guidance of DCPU. It will also work with urban local bodies for preparing a child friendly plan and also for its implementation.

Level 2. Gram Panchayat Level/Borough level (For Municipal Corporations)

Gram Panchayat Level Child Protection Committee (GPLCPC): The Gram Panchayat Level Child Protection committees will be established in each Gram Panchayat of the state to collect the information from the Village Level child Protection Committee, analyze the same, identify the actionable points and ensure upward transmission of the information collated to the Block Level Child Protection Committee for required intervention.

Borough Level CPC: will be established in each Borough of Municipal Corporation of the State to collect the information from the ward level CPCs, analyze the same, identify the actionable points and ensure upward transmission of the information collect to the Municipal Corporation level CPCs for required ().

Level 3: Block / Urban Local Bodies (Municipality, Notified area) level

Block Level Child Protection Committees (BLCPC): The BLCPC will support GPLCPC/ VLCPCs in planning, budgeting, implementing activities, capacity building as per the ICPS guidelines in coordination with District Child Protection Unit (DCPU). The BLCPC will also take periodic report from GPLCPCs, review performance, finalize action taken reports for submission to DCPU. The BLCPC will also work as a referral point for GPLCPCs to support them in addressing cases of child protection and child rights violation. BLCPC will also coordinate with all stakeholders at Block Level for immediate and long term strategy.

Urban Local Body Level CPC (ULBCPC): The ULBCPC will support ward level CPC in planning, budgeting & implementing activities, capacity building. The ULBCPC will also take periodic report from WLCPC, review performance, finalize action taken report for submission to DCPU. The ULBCPC will also work as referal point for WLCPCs to support them in addressing cases of child protection and child rights violation.

Formation of Child Protection committees

The process of CPCs formation will be initiated by District child Protection Unit. The process will include formation of BLCPC and in urban area the ULB level CPC. After the BLCPC is formed the GPLCPC and VLCPC formation process will be initiated.

Roles and Responsibilities of Child Protection Committees

- The Child Protection Committees at various levels will be responsible for the following:
- Conduct Need assessment in prescribed format for planning.
- Prepare annual plan and allocate budget as a part of Panchayat/ULB planning.
- Identify vulnerable pockets, maintain data of children and adolescents missing due to work, marriage, migration, school dropouts or by any other reason.
- Support referral linkages with Social protection schemes & services, support persons, conduct enquiries and submit reports on complaints received, action taken and preventive activities planned.
- Organize capacity building and orientation on child protection issues in collaboration with district/block/Panchayat administration along with CBOs, NGOs, adolescent groups, and other stakeholders.

- Awareness building initiatives among CPC members, adolescent groups, parents, community members, frontline workers and self—help group members and others.
- Promote children's participation in CPC meetings, trainings and awareness generation activities.
- Review and support implementation of planned activities within timeline at various levels.
- Report and document good practices for sharing with panchayat/block CPCs and DCPU.

Frequency of Meetings

- i. BLCPC/ULB level CPC should meet at least once in a quarter as called upon by the Member- Convener.
- ii. GPLCPC & VLCPC and WLCPC and Borough level CPC should meet at least once every month at the venue decided by the Member Convener.
- iii. Emergency meetings may be convened by the Chairperson as and when required.

Notification of Child Protection committees

- Names of the members appointed to this child protection committee should be made public by the competent authority.
- Efforts should be made to display the list of VLCPC/WLCPC member with contact number in prominent places in the locality, so that children and parents can access the members of the committee for reporting.
- The BLCPC information should be made at a public place in Block office with contact numbers to register complaints regarding child protection issues.

Tenure of the Child Protection Committee and Vacancies

- Nominated members can be nominated for three years and if required they can be re nominated.
- A member, at anytime, may resign from the membership or from any positions he/she holds in the CPC by writing to the Chairperson of the CPC.

The CPC, by resolution of 3/4th of the total members can expel or suspend the member on following grounds:

- a) Proof of misappropriation or misuse of power given under CPC,
- b) Proof of involvement in or instigating any kind of neglect, abuse, violence, or exploitation of children.
- c) Convicted by any court to flaw.

- d) Incapacitated to perform the duty due to insanity or unsound mind.
- e) The expulsion and suspension of any member will be limited to the authority as designated within the CPC only.
- f) All CPCs will fill the vacancy in maximum one month's time.

Guideline for CPC in Case of Any Legal issues

The VLCPC, GLCPC, WLCPC and BLCPC should make distinction between the incidences of Child Protection. In case of any cognizable offence or the case under purview of any court/judiciary/CWC/JJB, the CPC shall not intervene, organize arbitration or negotiation.

Whom to contact while dealing with different issues in child Protection?

Monitoring Mechanism: Reporting formats for different tiers are attached as annexure. For quality monitoring secondary indicators like School dropout rates, Rate of Child Marriage, Migration, Missing child data etc will be reviewed for future plan of action.

Training of Child Protection Committees/ Members

The Child Protection Committees once constituted shall undergo training/ orientation on Child Rights, on the role & responsibility of CPCs and other matter incidental thereto, which will be organized by West Bengal State Child Protection Society (WBSCPS) or through District Child Protection Unit/Committee directly or in collaboration with local NGOs& training cell of State Government/regional training centre of NIPCCD. The training and orientation should be organized as and when required. The CPCs should be oriented on:

- Child Rights- UNCRC and Constitutional Rights
- Legal frame work and structure of Child Protection
- Identification of vulnerable children
- Mapping exercise
- Planning and Budgeting exercise
- Referral and Follow up Mechanism
- Government schemes and services
- Exposure visits of CPC members
- Code of Conduct.

Child Protection Code of Conduct and Accountability Mechanism

It is important for all the CPC members in contact with children to:

ALWAYS	NEVER
a. Listen and respect children	a. Hit or otherwise physically assault or physically abuse children.
b. Encourage them to raise any concerns	b. Develop physical/sexual relationships with children.
c. Discuss with them about their rights, duties, and evolving challenges	c. Develop relationship with children that could in any way be deemed exploitative or abusive.
d. Respond immediately to ensure protection of children	d. Act in way that may be abusive or may place a child at risk of abuse.
e. Be aware of situations that may present risks for children and be prepared to respond to such situations.	e. Use language, make suggestions, or offer advice, which is inappropriate, offensive, or abusive.
f. Ensure that a sense of accountability exists between members so that poor practice or potentially abusive behavior should be addressed immediately.	f. Behave physically in a manner which is inappropriate or sexually provocative.
g. Act appropriately and effectively in co- operating with any subsequent process of investigation that is guided through the child protection process guided by the principle of "best interest of the child".	g. Sleep in the same room or bed as a child with whom they are working.
h. Work in partnership with parents/care givers and/ or other professionals to ensure quality protection services for children.	h. Ask children to do things that they can do themselves.
i. Ensure that a culture of openness exist any issues or concerns to be raised or discussed and addressed.	i. Participate in any action which is illegal, unsafe, or abusive to Children.
	j. Act in ways intended to shame, humiliate, belittle, or degrade children, or otherwise perpetrate any form of emotional abuse.
	k. Discriminate against, show differential treatment, or favour children to the exclusion of others.
	1. Take part in or promotes facilitati sex selective abortion, child marriages, corporal punishment, child labour etc.

Annexure

i) Meeting Minute Reports/ Reporting to Authority and Linkage with Higher Level

This is a suggestive format for CPCs to use in documenting the discussions of the meeting. Filling out this information, ensures that there is a record of the meeting and helps CPCs follow up on the points discussed in the meetings. An orientation should be provided to the Member Secretary of the village/ Gram Panchayat/ ward/ block CPCs on how to use and fill out this form.

ii) Protection Risks/Incidents/vulnerability Matrix (for CPCs)

This is a suggested matrix for CPCs to use in documenting individual case and /or overall child protection vulnerabilities in the community. Filling out this information, ensures that there is a record of an incident and helps CPCs work out different ways to address issues. The matrix can also be referred to when following up on cases. An orientation should be given to the Member Secretary of the village/GP/ward/block CPCs to understand how to use and fill out this form.
