RESOLUTION

It has been brought under the notice of Govt. that a considerable time is passed between calling of tenders and finally getting the rates approved by the Central Tender Committee for ICDS Projects resulting in irregular supply of food grains to the Anganwadi Centers of some projects and it has also been seen that prices vary in projects in the same district. Therefore, in order to minimise the time gap between the calling of tender and issue of supply order and keep parity of rates in the projects it has been decided that impartial modification of this Department Resolution No. 1703-SW dt. 15-06-95 a tender committee named as District Level Tender Committee for ICDS Projects will be formed with the following members:

The DLTC will approve the rates of food grains finally for all projects within the district. The project Level Tender Committees will as usual invite rates through tender abiding by the Finaical Rules. The DLTC will however, ensure that tenders of rates are floated by the CDPOs much ahead of expiry of the rates by on which the current supply of food grains is made in order that no project remains closed for want of food grains. But the DLTC will finalize the rates not exceeding the rate fixed by the CTC for each item of the food grains for the district. It will be desirable for the DLTCs fix up rates for as many projects as possible on a single day. All records of DLTC will be maintained by DPO as Member Convenor.

For the District Kolkata, Tender Committee will consist of following members:

Therefore, it has been further decided that the function of the CTC will be to regularly collect prices of food grains from Agricultural Marketing Directorate and fix up the ceiling of price of foodgrains mentioning period itemwise i.e. rice and das for each Dist. Level Tender Committee beyond which no DLTC will fix up any price of the concerned foodgrains. The CTC and finally MIC, women and Child Dev. & Social Welfare Deptt. will however, approve the rates finalized and recommended by the DLTCs where a Minister is the Chairman/Chairperson of a PLTC. The composition of the CTC will remain unchanged.

Moreover, the Project Level Tender Committees will function as usual.
