- 5. Until further orders, the Director of Social Welfare will be the drawing and disbursing officer in respect of the institution and the appointing authority in respect of its staff.
- 6. Sanction is also hereby accorded, by order of the Governor to the following non-recurring and recurring expenditure to be incurred in connection with the purchase of articles of furniture etc. for the maintenance and training of its inmates.

- 2. The State Government in the Home (Social Welfare) Department will be the appointing authority of the Gazetted post of Superintendent and the Director of Social Welfare, West Bengal will be the appointing authority in respect of the non-gazetted post as per the enclosed set up.
- 3. The Governor is also pleased to accord approval to the transfer of the administrative control of the Works-cum-Production Centre, Midnapore now under the Refugee, Relief & Rehabilitation Department to this Department with effect from a date to be intimated separately and to the absorption of such of the existing staff of the Centre as will be found suitable in the set up of the Girls' Home in scales of pay as may be admissible having regard to the posts which they have been respectively holding and the pay they have been drawing. Separate orders showing the absorption of the abovementioned staff will issue from the

Directorate of Social Welfare, West Bengal in due course. The Works-cum-Production Centre will, after transfer, form a part and parcel of the Home.

4. Sanction is also hereby accorded by order of the Governor to the following expenditure to be incurred in connection with the purchase of articles of furniture, etc. required for the aforesaid institution and to the scales of recurring expenditure to be incurred in connection with its maintenance:

The exact date will be intimated separately.

- 2. The aforesaid institution will continue to be located in its present building, "Subodh Niketan" within the campus of the I.T.I. Howrah, as agreed to by the Commerce and Industries Department until a separate arrangement for its accommodation is made, and will inpart training in the following courses:—
  - (a) Cutting and Tailoring—Two years course—Adminission Capacity—100
  - (b) Lady Brabourne Diploma Course—Three years course—Admission Capacity—50

India is one of the signatories to the resolution proclaiming 1981 as the International Year of Disabled Persons. This casts on the State Govt. a special responsibility to implement specific programme for the Welfare of the disabled. In 1981 the Govt. of West Bengal in the Deptt. of Relief and Welfare not only laid the ground work of a pattern of services for the handicapped that would remove the barriers of prejudice and discrimination against the disabled but also is actively engaged in making plans for the development of their potential as human resources.

- 2. In the aforesaid perception and to set the pace for realising the rights of the handicapped and for restoring to them their just and equal place in society the Governor has been pleased to sanction establishment of a vocational training centre at 3 Amalangsu Sen Road, (formerly 31 S. K. Deb Rd.), Patipukur, Calcutta-56 in the following trades:
  - (a) Printing Press-cum-Book Binding including Envelope making.
  - (b) Metal Unit (Lathe) comprising viceman (Fitter) Wori, Turning, Drilling etc.
  - (c) Cutting and Tailoring including Embroidery and Wool Knitting for Male and Female both.

With a view to imparting gainful training for their economic rehabilitation in the society as per scheme enclosed herewith.

- 3. The Governor has also been pleased to shift the Tailoring and Cutting Centre of Rashbehari Avenue, Calcutta sanctioned in G.O. No. 8076-SW dated 16.5.81 to the premises at 3 Amalangsu Sen Road, Calcutta-56 to substitute the Cutting and Tailoring Centre sanctioned in para-2(c) above with the variation that this centre will exclusively be utilised for imparting training to the physically handicapped only. Fund already allotted for this centre may be utilised for their present purpose.
- 4. In relaxation of the existing ban imposed in F.D. Memo. No. 7806-FB dated 10.11.80 the Governor has been pleased to sanction creation and filling up of the following temporary for the following trades:

Sir,

I am directed to say that as a part of the programme of institutional services for the welfare of children in need of care and protection a proposal for establishment of a destitute Home for girls, elderly women above 18 years of age and women in distress in their old age in North Bengal was under consideration of the Government for a long time. After careful consideration of the matter the Governor has been pleased to sanction establishment of a destitute home named "Sahid Bandana Smriti Mahila Abas, Cooch Behar" for 100 (One hundred) inmates of destitute girls elderly women above 18 years of age and distressed old men at Cooch Behar with immediate effect. As there is no such Home for this section of distressed old women in North Bengal 25% of the capacity will be kept reserved for them.

- 2. The Governor has also been pleased to sanction creation of temporary posts as detailed in the enclosed statement for administration of the Home with emmediate effect. The posts will continue for the period upto 28.2.82 for the present and will carry scale of pay as mentioned in the Statement along with other allowances sanctioned by the Government from time to time.
- 3. The Director, Social Welfare, West Bengal will be the administrative head of the institution in respect of all matters and appointing authority in respect of the non-gazetted posts sanctioned in para 2 above.
- 4. The Superintendent, Blind School, Cooch Behar, in addition to his own duties will take the charge of the "Sahid Bandana Smriti Mahila Abas," Cooch Behar with immediate effect and he will also act as drawing and disbursing officer of this home until further orders.
- 5. Following expenditure for maintenance of the home may be incurred in manner cited below:

- 2. Recuitment to posts sanctioned herewith should immediately be made as per existing employment policy of Government and also as per existing recruitment rules. The post of Weaving Instructor and Tailoring Instructor should be filled up only after the Scheme for Weaving and Tailoring Training is started. Equipments in this regard should also be made.
- 3. At present only 27 new posts as detailed in the Statement are created against his proposal for creation of 45 new posts. These 27 new posts have been considered adequate by Government at present to start the home. The post of Superintendent, for the home is being created separately with the approval of Cabinet. There is always a scope for review of staff positions after practical difficulties are focused in the administration of the home after certain period of running of the home.
- 4. He is, therefore, requested to come up for further posts, if considered necessary in due course after explaining the position. A report showing the latest position of the Scheme should also be sent to Government withing 4 months of this order.

### ANNEXURE 'A'

# A. Duties of Junior Social Worker

The main objective of Welfare Services for destitute is to rehabilitate them as normal citizens in the community they belong to. This cannot be attained unless the children placed with the institutions are studied and classified according to their needs and experience of life, so that individualized service could be rendered to them. Effort to rehabilitate them as normal citizens through marriage or otherwise is strengthened through the services of case work.

Thus these most important part of the institutional services are performed by the trained junior Social Worker who maintains the case history of all the inmates maintained in the Home.

For this purpose the junior Social Worker has to make regular home contacts with the guardian parent of the inmates to ascertain their economic and social background.

He/She is to follow up individual cases, to record the trend habits, behavioural changes and the improvements made and also to suggest correctional measures to be adopted in respect of the delinquent inmates. The services of trained Social Worker is provided both for offering case work service as well as supervision. Their services include pre-vocational guidance, recreational activities, correctional approaches and citizenship education. All these important functions are performed by the Junior Social Worker.

#### **B.** Duties of Matron

Their main duties are as follows:-

1. To provide motherly care and protection of the inmates who are in need of care and protection.

To supervise the works of helpers and cook.

- To keep special attention of the children below the age-group of 3-6 and adolescent inmates.
- 4. To prepare the menu chart and ensure cleanliness in the dormitory and kitchen.

To keep special vigilance on sick and delinquent inmates.

- To ensure all-round physical, mental and psychological development of the children.
- To keep vigilance on personal hygiene, recreational activities, physical and social care of inmates.

It is under whom that all the helpers posted in Home are to work.

### C. Duties of Helpers

The Main responsibility of the helpers is to assist the administration in the matter of looking after the well-being and all-round development of the children to satisfy their physicaly, mental and emotional needs. They being the grass root level workers having direct contact with the inmates, are to perform the following duties:—

1. To guard the children round the clock against committing any mischief or misbehaving with the fellow inmates or being ill-treated by the fellow inmates.

2. To ensure discipline in all walk of the lives of inmates.

3. To treat the children most affectionately and to establish a near home atmostphere in the homes by their leadership, affectionate touch of the hearts and fellow

4. To comfort them at the time of their sufferings in fever, arrange for special diets

and to see that they are properly taken care of.
5. Perform guarding duties while the inmates are in the dormitories and also within the premises of the Home.

6. To help the inmates in their recreational activities and also in other activities

such as gardening, farm works, etc.

7. To perform such other duties as are entrusted to them by the Superintendent.
