 - (a) Under the Directorate of Social Welfare all posts borne in scale of pay of Rs.440-1170/- and Rs.380-910/-,
 - (b) under the Controller of Vagrancy; West Bengal all posts borns in the scale of Rs.440-1170/- and Rs.380-910/-. /

Provided that not more than 40% of the posts under the service (both permanent and temporary take a together) shall be filled up by promotion. /

III. Qualifications and age of direct recruitment.

As prescribed for the West Bengal Civil Service (Executive)Examination.

IV. Eligibility for promotion :=

5 years experience in a feeder post or posts taken together ; /

For service in the Homes for the Blina ana/or neaf and numb, a degree or diploma or certificate in the training of Blind and or heaf and numb shall be an essential qualification. Any person not possessing the above qualification may be appointed in these Homes on condition that he shall have to receive in-service-training for teaching of the Blind and/or neaf and numb.

Note: Male candidates will be unsuitable for the posts meant for institution for females and female condidates unsuitable for the post meant for the institution for the males.
