issue I am directed by order of the Governor to state that the
Governor has been pleased to approve the revised rates of rent
for Anganwadi Centres of Rural Tribal & Urban I.C.D.S. Projects as
specified herein below:-

2. i) Rs. 200/- per month per Anganwadi Centre in Rural and
Tribal I.C.D.S. Project;
- ii) Rs. 750/- per month per Anganwadi Centre in Urban I.C.D.S.
Project.
- iii) However, the maximum rent for Anganwadi Centres
which are located in towns and falling under Rural and
Tribal ICDS projects with 50,000/- population and above
as per Census ~~2001~~ will be upto Rs. 500/- per month per
Anganwadi Centre even if the projects under which these
Anganwadi Centre come may happen to be Rural or Tribal
I.C.D.S. Project.
- iv) Further, for fixation of rent in the Urban I.C.D.S.
projects located in Kolkata and in the district the provision
of maximum rent limit of Rs. 750/- per month for such Anganwadi
Centres will be decided by considering following facts
 - a) area of the accommodation;
 - b) facilities like drinking water, kitchen, toilet and
and storing provision, if any;

3. In Kolkata the rent will be fixed by the Child Dev. Project Officers with the approval of the Addl. Director of Social Welfare, W.B.

5. In the Urban I.C. S. Projects in the districts rent will be fixed by the Child Dev. Project Officers with the approval of the respective District Magistrates.

5. I am further directed by order of the Governor to say that the Governor has been pleased to approve the revised rates of rent w.e.f. 01.02.2007 and would remain in force until further orders.

6. The expenditure on account of rent will be met from the funds released for implementation of ICDS (General) Scheme.

7. This order is issued with the concurrence of the Finance Deptt. vide their U.O. No. Gr. E-105 dt. 02.02.2007.

Subject : Implementation of revised cost norms of other existing components (other than SNP) under strengthen and re-structured ICDS Projects.

Sir,

I am directed by order of the Governor to say that the Govt. of India has since strengthen and restructured the ICDS scheme through a series of programmatic, management and institutional reforms, changes in norms, including putting of ICDS scheme in a Mission Mode for continued implementation of ICDS scheme in 12th five year plan vide Govt. of India's order No.1-8/2012-CD-I dt. 22.10.2012.

It has been enumerated that these revised norms will be applicable universally from the date of issue of Govt. of India's said order. This Deptt. has already introduced the revised rates under SNP beneficiaries in the three high burden districts (viz. Purulia, Birbhum and Dakshin Dinajpur) of West Bengal w.e.f. 01.01.2013 vide this Deptt's Memo No.8058-SW dated 26.12.2012 and again revised SNP has been introduced in more five high burden districts (viz. Burdwan, Uttar Dinajpur, Cooch Behar, South 24-Pgs & Jalpaiguri) with effect from 01.05.2013 vide this Deptt's Memo No.1577(2)-SW dated 07.05.2013.

Now, in view of above and after careful consideration of the matter, I am also directed by order of the Governor to say that the Governor has been pleased to implement the revised cost norms alongwith sharing pattern of expenditure between Govt. of India and State Govt. of other existing components (other than SNP) as per sub-para (v) & (vi) of Para 5 and two new components as per sub-para (ix) ibid of Govt. of India's said order for expenditure of the following items under ICDS with effect from 01.04.2013:

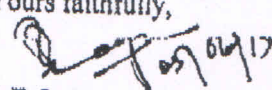

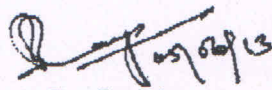
