

ORDER

As per provision of RTE Act, 2009 under section (11) State Govt. has the responsibility to make necessary arrangement for providing free pre-school education to children throughout the State. The Anganwadi Centres (AWCs) functioning under the Women and Child Development and Social Welfare Deptt. play a very crucial role for the cause of pre-school education and care for the health and nutrition of the child and the mother. For proper functioning of the AWCs it has, therefore, been decided by the State Govt. to construct pucca buildings on Govt. land in place of their temporary structures. The Women and Child Development and Social Welfare Department have already allotted funds in favour of District Magistrates for construction of building for Anganwadi Centres. But the District Magistrates are facing difficulties to execute the project due to non availability of suitable land.

In view of the above the Govt. in School Education Department accords approval for construction of Anganwadi buildings in the premises of primary schools owned and managed by District Primary School Councils/ Kolkata Primary School Council/ Siliguri Primary School Council without hampering the normal activities of the primary School provided sufficient land is available in the school premises. Chairmen of the District Primary School Councils are accordingly requested to issue 'No Objection Certificates' to the District Magistrate for construction of AWC buildings on primary school lands and extend co-operation to the district administration for erection of buildings and functioning of AWCs.


