Sub: List of Anganwadi Workers and Anganwadi Helper eligible for incentives in POSHAN Tracker

Please refer to our mail sent on 04/08/2022 regarding the aforesaid subject and subsequently, this office letter no. 1989/ICDM-Dte dated 25/08/2022 regarding the Project-wise month wise number of AWWs eligible for incentive from December, 2021 to April, 2022 and those of AWHs who are eligible for incentive from the month of March, 2022 to April, 2022.

However, the reports which are submitted from the districts are erroneous. It appears in many cases that the number of AWWs and AWHs eligible for incentive is more than that of the AWWs got data charges in those months. Even the AWWs and AWHs are proposed for those months when the District itself was not on onboarded in POSHAN Dashboard.

It should be borne in mind that only when the Project as well as the AWC are onboarded in POSHAN Tracker AND the Anganwadi Worker has started registering the beneficiary and other details of the AWC through mobile app to POSHAN Tracker, then only the AWW and AWH of that AWC will be considered eligible for incentive provided:

(a) The Anganwadi Worker has measured the length/height and weight of the children for at least 80% of children in 0-6 age group for the reporting month and while plotting the weight in the growth-chart, she has kept written records of the length/height of each child,

AND

(b) She has also completed at least 60% of home visits to pregnant women, lactating mothers and children up to two years of age and recorded that in the register (Register No. 8).

The names of the AWWs and AWHs who are eligible for incentives are to be determined **manually** by the CDPO from the available records and registers of the Anganwadi Centers. The data asked for **should not be** taken from the POSHAN Dashboard.

In this context, this is further to mention that the CDPO will send the names of the AWWs eligible for incentives after checking 5% of data randomly. While the month-wise name-list will be kept at the Project, the number of the AWWs should be sent to this end through DPO, who will in turn, randomly check the records of at least 2% of the data of AWWs and if satisfied, will send the Project-wise month-wise number of AWWs to this end. The names of the AWWs need not be sent.

In case of AWH incentive, the Supervisor will check the records of the AWCs to ascertain whether the AWC was opened for at least 21 days in a month and if so, the AWH would be eligible for incentive. Like AWWs, the month-wise name-list will be kept at the Project and the number of AWHs eligible for incentives will be sent to this end through the DPOs. The random checking as mentioned above for the AWWs should also be followed here.

The lists of AWWs eligible for data charges from December, 2021 to May, 2022 had already been communicated to you. The list of the same from June, 2022 to November, 2022 is enclosed herewith. This list should be used as a ready reference to determine whether the AWWs has used POSHAN App in the respective months or not and as mentioned earlier, the AWWs and AWHs will be eligible for incentive only when AWW has used POSHAN App for inputting data in POSHAN App as mentioned in a and b above.

You are requested to recheck your reports and submit the Project-wise number of AWWs eligible for incentive from December, 2021 to November, 2022 and that of AWHs from March, 2022 to November, 2022.

The list must be submitted to this end within 30 December, 2022.
