In continuation of this Office earlier Circular mentioned under reference wherein it was requested to ensure Financial Sanction and Allotment before passing of bill under the Head of Account "FD-18-2071-01-104-008-04-00-V" for payment of terminal benefit to contractual workers .

After careful consideration of the matter, I am directed to inform you that henceforth the payment of one-time terminal benefits to the contractual workers of all categories from the Major Head "2071-Pensions and Other Retirement Benefits" is subject to the availability of financial sanction and allotment under the concerned Scheme Head of Account. The Administrative Department shall send the proposal to the Finance Department for financial sanction & allotment for individual claims for payment of one-time terminal benefit from the concerned Scheme Head of Account under Major Head "2071-Pensions and Other Retirement Benefits". No fund should be drawn from any Scheme Head of Account under Major Head "2071-Pensions and Other Retirement Benefits" for payment of one-time terminal benefit to the contractual workers without financial sanction and allotment.

All the PAOs/TOs are also requested to apprise the concerned DDOs under their jurisdiction for their kind information and necessary action in the matter.
