**NOTIFICATION**

**Sub: New modalities for payment of Salary / remuneration for employees engaged in implementation of CSS - 'Saksham Anganwadi & POSHAN 2.0' w.e.f. 1<sup>st</sup> November, 2023**

In partial modification of this office G.O. No. 3374-WCD-14022/4/2022 dated 06.07.2022, the undersigned is directed by order of Governor to say that the Governor is pleased to accord administrative approval for introduction of a new mode for payment of Salary / remuneration of employees engaged in implementation of CSS - 'Saksham Anganwadi & POSHAN 2.0' under Govt. run ICDS Projects and NGO run ICDS Projects, in the following manner:

**I (A) FOR ALL EMPLOYEES OF GOVT. RUN ICDS PROJECTS**

At present, Salaries of DPOs, CDPOs, Supervisors and Statistical Assistants of Government run ICDS Projects are being drawn from IFMS through HoA "74-2235-02-102-00-099-01-01-V" to "74-2235-02-102-00-099-01-12-V" in accordance with U.O. No. 6385, dated 01.03.2022 and Finance Department G.O. No. 161(29)/FB, dated 02.06.2022.

Now, with the discontinuation of allotment of fund for Salary Component by MoWCD, GoI vide No. CD-II-14/2/2023-CD-II (e-105674), dated 01.08.2023, the sharing pattern of the salary becomes Central Share : State Share :: 0:100 i.e. the entire fund for salary / remuneration for employees under Govt. run ICDS Projects shall be borne on the State Exchequer.

Now, the salaries of DPOs, CDPOs, Supervisors and Statistical Assistants (previously APIP Category employees) shall be considered from the following existing Head of Accounts **with effect from 1<sup>st</sup> November 2023:**

2. 74-2235-02-001-012-01-02-V :: Dearness Allowance

**1 (B) FOR ALL EMPLOYEES UNDER NGO run ICDS Projects**

The remuneration of DPOs, CDPOs, Supervisors and Statistical Assistants of NGO run ICDS Projects shall be considered from the HoA "74-2235-02-001-00-012-36-00" **with effect from 1<sup>st</sup> November 2023.**
