**Sub : Memorandum relating to engagement to position of AWW from AWH by promotion.**

In partial Modification of this Deptt. Memorandum No.4040-SW/3S-225/05 dated 20.12.2013 relating to procedures for giving appointment to AWWs by promotion from AWHs under Govt. run and NGO-run ICDS Projects, the undersigned is directed, by order of the Governor, to say that the Governor, after careful consideration, has been pleased to decide in the public interest, to modify the educational qualification in the guidelines for recruitment to the post of AWWs by promotion from AWHs under Govt. run and NGO run ICDS Projects as under :-

In the light of the above, Para (i) and (iv)(c) of Memorandum No. 4040-SW/3S-225/05 dated 20.12.2013 are modified hereinunder as follows :

- (i) in the matter of promotion minimum qualification will be Class-XII pass for all categories
- (iv) There will be a test for giving promotion to the post of AWWs from AWHs in the following manner:
  - (c) Written test (multiple type objective questions on Mathematics (Class-X standard) and English language (Class-X standard), Nutrition, Public Health, status of Women & General Knowledge.

All other contents of the Memo. No. 4040-SW/3S-225/05 dated 20.12.2013 remain unchanged.
