Consequent upon revision of pay and allowances under the WBS (ROPA) Rules, 2009, the undersigned is directed by the order of the Governor to say that the Governor has been pleased to direct that in supersession of all previous orders, the pay of the Group-D employees paid out of contingencies shall be fixed as follows with effect from  $f^t$  June, 2009:-

a) If employed whole-time and throughout the year	<ul> <li>a) Pay in the pay Band scale of Rs. 4900 - 16200/- (PB-I) with Grade pay of Rs. 1700/- plus allowances as admissible to whole-time Govt. employees.</li> </ul>
b) If employed whole-time but not throughout the year	b) Fixed pay not exceeding Rs.6600/- plus allowances as admissible to whole-time Govt. employees.
c) If employed part-time throughout / not throughout the year	c) Fixed pay not exceeding Rs.2000/- per month without any allowances

The provisions of the West Bengal Services (Revision of Pay and Allowances) Rules, 2009 shall apply mutatis-mutandis only to the contingent staff mentioned in item (a) above.
