Advantage of marks/point may be included based on last performance during the calculation of weightage for next year renewal.

It was informed in the meeting by the Sub-Divisional Officers of Diamond Harbour, Kakdwip, Alipore (Sadar) and Baruipur Sub-Divisions that all the concerned Sangha Samabaya have applied for renewal and their performance was satisfactory during the last year in terms of the work of supply of Masur Dal, Mustard Oil & lodised Salt to the respective AWCs.

Smt. Sanghamitra Ghosh, IAS, Principal Secretary, Department of WCD and SW took the Chair.

It was decided in the meeting that 100 % subsidized fortified Rice under WBNP will be lifted from the CPC stock under Food & Supplies Department, Govt. of West Bengal to meet up the requirement of fortified Rice under SNP in ICDS.

It was also decided in the meeting that all the Govt. agencies approved by Finance Department and SHGs/Sanghas/Mahasanghas approved by this Department/District under SNP will have to mandatorily supply the samples of the food grains (MusurDal(small variety), Mustard oil & Iodised Salt) to the CDPOs, DPOs of the respective Districts for verification, before supply of the same to the ICDS Projects. Mustard Oil and Iodised Salt shall be supplied strictly adhering to the enlisted brands as indicated below.

Officers present from the Directorate of Agri-Marketing as well as Food and Supplies Department informed again that the Price of Shiv Brand Mustard oil has been quoted based on the availability of the product at Malda and Murshidabad District only.

Fine Rice (IR 36) would be procured only in the event of failure of lifting or shortfall of supply of Central Pool Stock of Food & Supply Department as intimated in writing by Food & Supply Department and with prior permission of this Department.

The rates for Kachhi Ghani Mustard Oil as submitted by Directorate of Agri-Marketing and Food and Supplies Department were received. It was learnt as always the rate quoted for Shiv Brand i.e. R.114/- was found lowest. However, the Committee decided to recommend the second lowest i.e. Rs.126/- because the Shiv Brand oil is available only in Murshidabad and Malda Dist.

Comparing the rate charts of Wholesale & Retail Market Price of the dietary articles as submitted by the Department of Food & Supplies as well as Directorate of Agricultural Marketing in terms of their letter No.4863-FS/Sectt/Food/4M-19/2019 dated.02.11.2023 and letter No.3108 dated 02.11.2023, respectively, the following rates were recommended by the SNP Committee:
