Sub: Extension of the period for submission and evaluation/acceptance of online SAR by Officer Reported Upon and Reporting Authority/Reviewing Authority/Accepting Authority respectively in HRMS for the Appraisal Year 2020-21.

In terms of Memo. No. 2748-F(P2) dated 27<sup>th</sup> April, 2018, all Group A employees of the State Government are required to submit online Self Appraisal Reports (SAR) and to process them in HRMS every year within certain dates specified in the order. The last dates for submission/evaluation/acceptance of SAR by different authorities for Appraisal Year 2020-21 were extended vide order no. 1452-F(Y) dated 30/04/2021.
