In continuation of this Department's earlier Memo No.6668(2)-SW dated 29.11.2023, I am directed to say that the Committee on SNP constituted vide this Deptt. Order No. 5096-SW dated 09.12.2009 in terms of the policy of the Finance Department communicated vide their U.O. No. 225-Group-E dated 20.11.2009 made the following recommendations in the meeting held on **06.02.2024** regarding the revision of rates of food commodities for a further

period of three months i.e. from **01.02.2024** to **30.04.2024**.

Now, I am directed to say that the Governor has been pleased to accept the above recommendations of the committee in pursuant to this Department's Memo. No.I/490451/2024, dated 29.02.2024.

The Governor has also been pleased to introduce the revised rates w.e.f. **01.02.2024** and the same will remain valid up to **30.04.2024**.

The revised rates will be applicable to WBECSC Ltd., CONFED, NCCF and WBTDCC Ltd. and all Federations/Clusters of Self Help Groups/Self Help Group/Sanghas/Mahasanghas under WBSLRM, those who are engaged in supplying the food stuff of SNP.

This order is applicable to both Govt. run ICDS Projects and NGO run ICDS Projects. All other terms and conditions laid down in this Deptt.'s G.O.No.4898(2)-SW dated 22.12.2005 will remain unchanged.
