Smt. Sanghamitra Ghosh, IAS, Principal Secretary, Department of WCD and SW took the Chair.

It was decided in the meeting that 100 % subsidized fortified Rice under WBNP will be lifted from the CPC stock under Food & Supplies Department, Govt. of West Bengal to meet up the requirement of fortified Rice under SNP in ICDS.

In response to the Department's memo no 2116-SW/WCD-14038/1/2022 dated 20/4/23, Samples of Musur dal(small variety) supplied by Food & Supplies Department were verified by the Committee. However in response to the Department's memo no 2058-SW/WCD-14038/1/2022 dated 18/4/23,no samples of Musur dal was Agriculture(Marketing) Department. Director of Agricultural Marketing has informed vide her Memo No.1332, dated 24/04/2023 that price quoting is always location based and the officials of their Directorate collect price of Fair Average Quality (FAQ) variety of wholesale and retail prices of agricultural products on regular basis by visiting major wholesale markets of agricultural products during the peak hour of transaction. After collection of wholesale and retail products, the same are preserved and recorded only for providing the same to the different organization as and when asked for. For all such commodities, samples are neither collected from the markets nor are preserved in different Offices of the Directorate. Therefore, it was not possible for them to supply samples of musur dal(small variety) according to the prices as notified for any agricultural products.

Hence the sample of Masur Dal(small variety) as submitted by the Food and Supplies Department was accepted by the Committee. It was decided that those samples would be shared to all the District authorities through the Directorate, ICDS.

It was also decided in the meeting that all the Govt. agencies approved by Finance Department and SHGs/Sanghas/Mahasanghas approved by this Department/District under SNP will have to mandatorily supply the samples of the food grains (Fine Rice, Musur Dal, Mustard oil & Iodised Salt) to the CDPOs, DPOs of the respective Districts for verification with the above mentioned sample before supply of the same to the ICDS Projects. Mustard Oil and Iodised Salt shall be supplied strictly adhering to the enlisted brands as indicated below.

Director of Agri-Marketing as well as Food and Supplies Department further informed that the Price of Shiv Brand Mustard oil had been quoted based on the availability of the product at Malda and Murshidabad District only.

Fine Rice (IR 36) would be procured only in the event of failure of lifting or shortfall of supply of Central Pool Stock of Food & Supply Department as intimated in writing by Food & Supply Department and with prior permission of this Department.
