It was decided in the meeting that 100 % subsidized Rice under WBNP will be lifted from the FCI/CPC stock under Food & Supplies Department, Govt. of West Bengal to meet up the requirement of Rice under SNP in ICDS. It was also decided in the meeting that all the Govt. agencies approved by Finance Department and SHGs approved by this Department under SNP will have to mandatorily supply the samples of the food grains (Fine Rice, Musur Dal, Mustard oil & Iodised Salt) to the CDPOs, DPOs of the respective Districts as well as the Director of ICDS, W.B for verification before supply of the same to the ICDS Projects. Mustard Oil and Iodised Salt shall be supplied strictly adhering to the enlisted brands as indicated below.

Fine Rice (IR 36) may be procured only in the event of failure of lifting or shortfall of supply of FCI/Central Pool Stock of Food & Supply Department as intimated in writing by FCI/Food & Supply Department and with prior permission of this Department.

Comparing the rate charts of Wholesale & Retail Market Price of some dietary articles as submitted by the Department of Food & Supplies as well as Directorate of Agricultural Marketing in terms of their letter No.4082-FS/Sectt/Food/4M-11/21 dated.25.11.2021 and letter No.3890 dated 25.11.2021, respectively following rates are recommended by the SNP Committee:
