

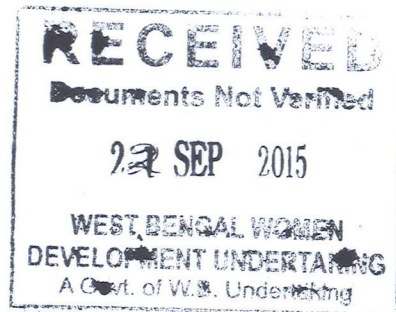

Sub : Regulations for Promotion to the post of Asstt. Directors, Dy Directors and Joint Directors.

Sir/Madam,

I am directed to state that the following decisions have been taken by this Department for promotion to the above posts.

- 1) For Promotion to the post of Asstt. Director only that officers who have discharged at least 1(one) year in the senior post to DPO/DSWO or at least 2 years as Supdt./Manager of Govt. Home would be considered.
- 2) For promotion to the post of Asstt. Director, officers should have average ACRs marking of at least 20pt out of 33 in their last senior posting as mentioned at Sl. No.01.
- 3) For promotion to the post of Deputy Director only the Assistant Directors who have performed at least for one year in that capacity and have ACR marking of 25 out of 33 should be taken into consideration.
- 4) For promotion to the post of Joint Director only, those officers originating in the WBJSWS who have performed at least 6 months in the level of Deputy Director and have the ACR marking 28 out of 33 should be taken into consideration.
- 5) All such officers must have to clear integrity Report from the Reporting Officers.
