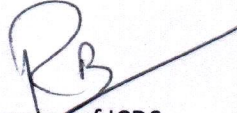

The appointment is subject to following Terms and Conditions:-

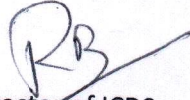
1. The appointment is purely on temporary basis and may be terminated on one month notice from this end within the probation period of 2(two) years from the date of joining.
